

**RESOLUTION G2023-100**

**RESOLUTION AUTHORIZING THE PURCHASE OF REPLACEMENT GRILLS  
FOR SYMMES PARK IN THE AMOUNT OF SIXTEEN THOUSAND FIFTY-  
THREE DOLLARS AND NO CENTS (\$16,053.00) FROM GL NAUSE**

**WHEREAS**, it has been determined by the Trustees that the grills at Symmes Park requires maintenance and needs to be replaced due to their age and a tree falling on one of the grills ; and

**WHEREAS**, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public and to keep the employees and the public safe; and

**WHEREAS**, the Director of Public Works has reviewed all bids and finds that GL Nause to have the best bid; and

**WHEREAS**, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby authorizes the purchase of replacement grills at Symmes Park in the amount of \$16,053.00 from GL Nause.

**Section 2.** The funds for the grills shall be taken from the American Rescue Plan Fund (ARPA #2272).

**Section 3.** The Fiscal Officer is hereby authorized to make payment to GL Nause in the amount of \$16,053.00 upon final approval of the Public Works Director.

**Section 4.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

**Section 5.** It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this

Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**Section 6.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
