

**RESOLUTION G2023-101**

**RESOLUTION PETITIONING THE BOARD OF HAMILTON COUNTY  
COMMISSIONERS TO TRANSFER OWNERSHIP OF CERTAIN COUNTY  
PROPERTY (PARCEL 620-0210-0422-00) TO THE SYMMES TOWNSHIP BOARD OF  
TRUSTEES FOR TOWNSHIP ROAD PURPOSES**

**WHEREAS**, the Board of Commissioners of Hamilton County is the current owner of property identified by Hamilton County Auditor ID number 620-0210-0422-00; and

**WHEREAS**, the Township has previously paid to replace the bridge on this portion of roadway; and

**WHEREAS**, the Township continues to maintain the entirety of the roadway; and

**WHEREAS**, Township now desires to petition the County to transfer ownership of this property in order to unify ownership and clarify maintenance responsibility for Blong Road.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Board of Trustees of Symmes Township, Hamilton County, Ohio, hereby petition the Board of Commissioners of Hamilton County to transfer ownership of certain property identified by Hamilton County Auditor ID number 620-0210-0422-00 to the Township for Township Road purposes.

Section 2. The Township Administrator is further authorized to execute any and all documents necessary to complete the transfer of said property.

Section 3. The Trustees of Symmes Township upon a majority vote do hereby dispense with the requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.

Section 4. This Resolution shall take effect on and after the earliest period allowed by law, following the filing of this Resolution with the Symmes Township Fiscal Officer.

Section 5. It is hereby determined that all formal actions of the Board of Trustees relating to the adoption of this Resolution were taken in an open meeting of the Board of Township Trustees and that all deliberations of such Board of Trustees were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
