RESOLUTION AUTHORIZING A CHANGE ORDER IN THE MONTGOMERY ROAD MEDIAN LANDSCAPING PROJECT CONTRACT FOR RIVEROAKS SERVICES IN THE AMOUNT OF \$865.00

WHEREAS, on October 10, 2023, the Township entered into an agreement with RiverOaks Services to install landscaping materials in the medians on Montgomery Road.; and

WHEREAS, the total amount of the agreement was for \$64,977.50; and

WHEREAS, additional work was needed and not anticipated during the design phase of the project whereby the contractor recommends that we install erosion control fabric with creek gravel at each end of the landscaping beds of all four (4) of the medians; and

WHEREAS, the Director of Public Works is recommending that the contract be increased to include this additional work in the amount of \$865.00; and

WHEREAS, it is necessary to maintain the cemeteries, building grounds, parks and road rights-of-way for the safe and effective operation of Symmes Township public works services and the general public.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes additional work and payment to RiverOaks Services for the Montgomery Road Median Landscaping Project.

Section 2. The Township Administrator is authorized to complete any necessary additional paperwork needed to authorize the additional work.

Section 3. The additional funds for the project shall be taken from the General Fund (#1000).

Section 4. That General Fund line item 1000-760-730-0000 be increased \$865.00 to a total of \$431,334.58.

Section 5. The Fiscal Officer is hereby authorized to make additional payments to RiverOaks Services in the total amount of \$865.00 for a total amount of \$65,842.50 when finished and the Public Works Director has given approval of the pay request.

Section 6. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 7. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 8. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
