**RESOLUTION AUTHORIZING A CHANGE ORDER IN THE TANAGERHILLS
PIPE REPLACEMENT PROJECT CONTRACT FOR STILES AND SONS IN THE
AMOUNT OF \$17,530.00**

WHEREAS, in May of this year, the Public Works Director indicated to the Township Administrator and Board of Trustees that there is a pipe that drains the water from I-275 in a public utility easement into the Tanagerhills Subdivision that needed repairs.; and

WHEREAS, a contract was awarded for a total of \$49,791.00 to Stiles and Sons; and

WHEREAS, additional work is needed and not anticipated during the evaluation phase which required the excavation and hauling of unusable dirt from the construction site to a dump, then hauling in good dirt for proper compaction around the new pipe; and

WHEREAS, the Director of Public Works is recommending that the contract be increased to include this additional work in the amount of \$17,530.00; and

WHEREAS, it is necessary to maintain the cemeteries, building grounds, parks and road rights-of-way for the safe and effective operation of Symmes Township public works services and the general public.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes additional work and payment to Stiles and Sons for the Tanagerhills Pipe Replacement Project.

Section 2. The Township Administrator is authorized to complete any necessary additional paperwork needed to authorize the additional work.

Section 3. The additional funds for the project shall be taken from the Road Levy Fund (#2193).

Section 4. The Fiscal Officer is hereby authorized to make additional payments to Stiles and Sons in the total amount of \$17,530.00 for a total amount of \$67,321.00 when finished and the Public Works Director has given approval of the pay request.

Section 5. Upon majority vote does hereby dispense with the requirement that this

Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 6. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 7. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
