RESOLUTION MODIFYING RESOLUTION G2024-25 AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO PURCHASE RECYCLED TABLES, BENCHES AND CHAIRS FROM HANDCRAFTED AMISH FOR SEVEN GABLES AND HOPEWELL MEADOWS PARKS IN THE AMOUNT OF TWENTY THOUSAND FIVE HUNDRED FIFTY DOLLARS AND NO CENTS (\$20,550.00)

WHEREAS, it has been determined by the Trustees that more tables and benches are needed for the parks due to the increased usage at Seven Gables and Hopewell Meadows Parks; and

WHEREAS, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the public; and

WHEREAS, the Director of Public Works recommends that we purchase these additional tables and benches that are made from recycled materials; and

WHEREAS, additional chairs were purchased for Hopewell Meadows Park which has increased the price in the amount of \$2,740.00; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to purchase recycled tables w/umbrellas and benches from Handcrafted Amish in the amount of Twenty Thousand Five Hundred Fifty Dollars and No Cents (\$20,550.00).

Section 2. The funds for the tables, benches and chairs shall be paid from the Parks Fund (#2171) and General Fund (#1000).

Section 3. The Fiscal Officer is hereby authorized to make payment to Handcrafted Amish in the amount of \$20,550.00 upon final approval of the Public Works Director.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 5. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
