

**RESOLUTION G2024-52**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO  
ENTER INTO AN AGREEMENT WITH HEMBREE CONSTRUCTION  
SERVICES (HCS) TO INSTALL SIDEWALKS ON UNION CEMETERY ROAD IN  
THE AMOUNT OF TWENTY-ONE THOUSAND ONE HUNDRED TWENTY-ONE  
DOLLARS AND NO CENTS (\$21,121.00)**

**WHEREAS**, the Trustees have determined that they would like to expand the sidewalk network throughout the Township which includes connecting parks to the neighborhoods located within the Township, making connections between neighborhoods, and connecting neighborhoods to commercial service districts.; and

**WHEREAS**, the Township has Tax Increment Financing (TIF) Funds available for this project as it will connect several neighborhoods in the township to the commercial district where the TIF was established and benefit the district; and

**WHEREAS**, bids were accepted and reviewed by the Public Works Director and the Township Public Works Director recommends that the Trustees award the contract to Hembree Construction Services (HCS) in the amount of Twenty-One Thousand One Hundred Twenty-One Dollars and No Cents (\$21,121.00); and

**WHEREAS**, a portion of the sidewalks for the new house built at 9428 Union Cemetery Road will be the responsibility of the homeowner, Farida Aripova, 9448 Union Cemetery Road because sidewalks are now required on designated County Roadways per the Sidewalk Map for Symmes Township; and

**WHEREAS**, Farida Aripova, has agreed to compensate Hembree Construction for their portion of the sidewalks separately which includes the entire frontage of 9428 Union Cemetery Road per the Sidewalk Reimbursement Agreement; and

**WHEREAS**, pursuant to Ohio Revised Code §5571.01, the Board of Trustees may construct, reconstruct, resurface, or improve any public road or part thereof under its jurisdiction within its township.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes

Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby authorizes the Township Administrator to sign an agreement with Hembree Constructions Services (HCS) to install sidewalks on Union Cemetery Road in the amount of Twenty-One Thousand One Hundred Twenty-One Dollars and No Cents (\$21,121.00).

**Section 2.** The Township Administrator is authorized to sign the contract and complete any necessary paperwork to award the bid.

**Section 3.** The funds for the sidewalks shall be taken from the Tax Increment Financing (TIF) Fund (#2902).

**Section 4.** The Fiscal Officer is hereby authorized to make payment to Hembree Construction Services in the amount of \$21,121.00 once the work is finished and the Public Works Director has given final approval of the project.

**Section 5.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

**Section 6.** That it is hereby found and determined that all formal actions of the Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**Section 7.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
