

**RESOLUTION G2024-103**

**RESOLUTION AMENDING RULES AND REGULATIONS AND REVISING FEE SCHEDULE FOR SYMMES TOWNSHIP CEMETERIES**

**WHEREAS**, the Board of Trustees of Symmes Township, Hamilton County, Ohio established and adopted rules and regulations for township cemeteries on March 6, 1990 by passed of Resolution C-9001; and

**WHEREAS**, the Board of Trustees of Symmes Township, Hamilton County, Ohio established and adopted a Rate Schedule for the cost of the grave spaces, opening and closing fees, foundations, and cornerstones pursuant to Resolution C-9001; and

**WHEREAS**, revisions to the adopted rules and regulations and to the Rate Schedule have been made pursuant to Resolutions C-9601 (Adopted 5/21/96), C-0001 (Adopted 5/19/00), C-0201 (Adopted 9/3/02), C-0301 (Adopted 7/1/03), C-0302 (Adopted 10/7/03), C-0401 (Adopted 9/7/04), C-0701 (Adopted 6/5/07), C2011-01, C2011-02 (Adopted 6/1/11), C2013-01 (Adopted 10/1/13), C2015-01 (Adopted 9/1/15), C2016-01 (Adopted 10/4/16), C2018-01 (Adopted 9/11/18); G2022-32 (Adopted 3/1/22); G2022-130 (Adopted 12/29/22); G2023-102 (Adopted 10/10/23; and

**WHEREAS**, the Board of Trustees has determined the need to amend the rules and regulations and to revise the Rate Schedule.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio that:

**Section 1.** That the attached schedule of fees for the Cemeteries are hereby revised as follows:
