RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO PURCHASE PLAYGROUND EQUIPMENT FROM PLAYGROUND EQUIPMENT SERVICES (PES) TO REPLACE THE PLAY STRUCTURE AT SHADY RIDGE SHELTER, SWINGS AT LEMING SHELTER AT SYMMES PARK IN THE AMOUNT OF TWO HUNDRED THIRTY-NINE THOUSAND SEVEN HUNDRED NINETY-NINE DOLLARS AND NO CENTS (\$239,799.00) AND ENTER INTO AN AGREEMENT WITH JK MEURER PAVING TO REPLACE THE BASKETBALL HOOPS AND RESURFACE THE ASPHALT AT SYMMES PARK IN THE AMOUNT OF SIXTY TWO THOUSAND FOUR HUNDRED FORTY DOLLARS (\$62,440.00)

WHEREAS, it has been determined by the Trustees that they would like to replace the current playground structure at Shady Ridge Shelter in Symmes Park, replace the swing structure at Leming Shelter in Symmes Park and replace the basketball hoops and resurface the asphalt at Symmes Park because the structures and basketball courts have fallen into disrepair; and

WHEREAS, the Township did receive grant monies to help fund the replacement of the equipment in the amount of One Hundred Forty Thousand Dollars and No Cents (\$140,000.00) from Ohio Department of Natural Resources and will receive a reimbursement for a portion of the project when completed that shall be deposited in the General Fund; and

WHEREAS, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, Playground Equipment Services (PES) meets all State of Ohio bidding requirements therefore the Township would not be required to bid out the equipment to multiple vendors; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes


Township, Hamilton County, Ohio:

- Section 1.** The Symmes Township Trustees hereby authorizes the Township Administrator to purchase playground equipment from Playground Equipment Services (PES) in the amount of Two Hundred Thirty-Nine Thousand Seven Hundred Ninety-Nine Dollars and No Cents (\$239,799.00) and equipment and services from JK Meurer Paving in the amount of Sixty-Two Thousand Four Hundred Forty Dollars and No Cents (\$62,440.00).
- Section 2.** The funds for the park improvements shall be taken from the Park Fund (#2171) and General Fund (#1000).
- Section 3.** The Fiscal Officer is hereby authorized to make payment to Playground Equipment Services (PES) in the amount of \$239,799.00 and JK Meurer Paving in the amount of \$62,440.00 once the equipment has been delivered and installed and the Public Works Director has given final approval of the project.
- Section 4.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.
- Section 5.** It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- Section 6.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.




