RESOLUTION APPROVING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH THE HAMILTON COUNTY SHERIFF'S OFFICE TO PROVIDE ADDITIONAL POLICE PROTECTION SERVICES THROUGH EXTRA PATROL DETAILS THROUGHOUT SYMMES TOWNSHIP'S PARKS THROUGH DECEMBER 31, 2025

WHEREAS, pursuant to Sections 504.16 of the Ohio Revised Code, the Township may obtain police protection services for the Township on a regular basis by contract pursuant to Sections 311.29, 505.43 or 505.50 of the Ohio Revised Code; and

WHEREAS, pursuant to Section 505.43 of the Ohio Revised Code, the Township may contract with the Sheriff and the Board for police protection services; and

WHEREAS, pursuant to Section 311.29 of the Ohio Revised Code, the Sheriff may enter into a contract with the Township to render police protection services and the Township shall reimburse Hamilton County, Ohio for the costs incurred by the Sheriff for providing such police protection services; and

WHEREAS, the Sheriff, the Board, and the Township, pursuant to Sections 311.29 and Section 505.43 of the Ohio Revised Code, the Hamilton County Sheriff's Office and Symmes Township Board of Trustees have entered into such an agreement for police protection services; and

WHEREAS, the contract is in effect beginning on April 1, 2023 and end on March 31, 2026; and

WHEREAS, it has been determined extra patrol details within the parks are necessary due to an increase in violations of park rules; and

WHEREAS, the Symmes Township Board of Trustees hereby approve contributions to the contract and add additional police protection services through extra patrol details through all Symmes Township's Parks through December 31, 2025 with an amount not to exceed \$15,000; and

WHEREAS, all other provisions of the contract shall remain in effect for the duration of the contract; and

WHEREAS, the additional extra patrol park details shall take effect and be in effect beginning on August 12, 2025.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. That the Symmes Township Board of Trustees authorize the Township Administrator to sign an agreement for additional police protection services within the Symmes Township Parks for extra patrol details with the Hamilton County Sheriff's Office.

Section 2. The Township Fiscal Officer is hereby authorized and directed to make payments to the Hamilton County Sheriff's Office not to exceed \$15,000 from the Safety Services Fund (#2196) for additional police patrol services within the parks for August 12, 2025 through December 31, 2025.

Section 3. That the appropriations line item for 2196-220-370-0000 be increased \$15,000 to a total amount of \$806,451.00.

Section 4. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
