



RESOLUTION G2025-70

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH PAVEMENT TECHNOLOGY INC. FOR THE ROAD DEPARTMENT TO PURCHASE RECLAMITE IN THE AMOUNT NOT TO EXCEED TWENTY-EIGHT THOUSAND ONE HUNDRED FIFTEEN DOLLARS AND SEVENTY-SIX CENTS (\$28,115.76)

WHEREAS, the Township Road Department is responsible for roads and sidewalks maintenance throughout the township; and

WHEREAS, the Director of Public Works has indicated to the Township Administrator that we need to purchase Reclamite asphalt rejuvenator for various roadways in Symmes Township which will prolong the life of the roadway; and

WHEREAS, the Township would also like to apply the reclamite the roadway surfaces for the 2025 road paving program; and

WHEREAS, it has been determined by the Township Trustees that Reclamite asphalt rejuvenator is a necessary item that needs to be purchased every year to help preserve the roadways within the township and is authorizing the Township Administrator to purchase it.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorize the Township Administrator to purchase Reclamite Asphalt Rejuvenator for the Road Department from Pavement Technology Inc. in an amount not to exceed Twenty-Eight Thousand One Hundred Fifteen Dollars and Seventy-Six Cents (\$28,115.76).

Section 2. The funds for the reclamite shall be taken from the Permissive Motor Vehicle License Fund (#2231).

Section 3. The Fiscal Officer is hereby authorized to make payment to the

necessary vendors once approval has been given by the Public Works Director.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.


Section 5. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
