



RESOLUTION G2018-82

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO SIGN AN AGREEMENT WITH ARTWORKS FOR PROFESSIONAL SERVICES FOR THE HOME OF THE BRAVE PARK MURAL PROJECT IN AN AMOUNT NOT TO EXCEED \$23,466.00

WHEREAS, the Board of Trustees has previously discussed painting a mural in Home of the Brave Park on an existing maintenance building within the park; and

WHEREAS, Artworks presented an agreement to the Board at the last meeting and the Board of Trustees approved the original agreement with Artworks in an amount not to exceed \$12,998.00; and

WHEREAS, the Board of Township Trustees have identified the need to hire artworks to do additional tasks associated with painting the mural on the building at Home of the Brave than what was previously approved; and

WHEREAS, the Trustees desire to have Artworks create a wrap-around mural on all four exterior elevations of the Maintenance Building at Home of the Brave Park on Lebanon Road which will blend features of the employment of four (4) local youth apprentices working under the direction of (2) professional artists in partnership with community volunteers to paint a wrap-around mural to be executed as a Summer 2019 project and will be managed by Artworks; and

WHEREAS, the Artworks project is expected to last approximately 6 weeks to paint a unique design on approximately 1200 sq ft of wall space; and

WHEREAS, the Board of Township Trustees would now like to enter into an agreement with Artworks to complete this mural to make Home of the Brave Park an attractive place and to transform the residents and places through investments in creativity.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Symmes Township, Hamilton County, Ohio takes the following action:

Section 1. That the Township Administrator is authorized to sign an agreement or necessary paperwork with Artworks, 20 E. Central Parkway, Cincinnati, Ohio 45202, to provide professional services for the Symmes Township Home of the Brave Park Mural, in an amount not to exceed Twenty-Three Thousand Four Hundred Sixty-Six Dollars and No Cents (\$23,466.00).

Section 2. That the Fiscal Officer is hereby authorized and directed to expend funds to pay Artworks from the Park Fund (#12) in an amount not to exceed Twenty-Three Thousand Four Hundred Sixty-Six Dollars and No Cents

(\$23,466.00.00).

Section 3. The Board of Trustees of Symmes Township upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.



Section 5. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.


