



RESOLUTION G2018-76

RESOLUTION AUTHORIZING A CHANGE ORDER IN THE CONCRETE CURB CONTRACT WITH RA MILLER CONSTRUCTION NOT TO EXCEED \$12,800.00 TO INSTALL ADA RAMPS

WHEREAS, on July 14th and 21st Symmes Township advertised for the curb replacement project in the Pemmican Run Subdivision in the newspaper and website and set a bid date of July 31, 2018 at 2:00 p.m.; and

WHEREAS, a contract was awarded to RA Miller for a total of \$278,500.00 to replace curbs/gutter in the Pemmican Run Subdivision; and

WHEREAS, the Director of Public Works has recommended that we also replace ADA ramps to make them all uniform in size in that same subdivision and to meet current ADA standards; and

WHEREAS, pursuant to Ohio Revised Code §5571.01, the Board of Trustees may construct, reconstruct, resurface, or improve any public road or part thereof under its jurisdiction within its township.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

- Section 1.** The Symmes Township Trustees hereby authorizes the change order in the contract with RA Miller Construction in the amount not to exceed \$12,800.00 to install ADA ramps in the Pemmican Run Subdivision.
- Section 2.** The Director of Public Works is authorized to complete any necessary additional paperwork needed to complete the change order.
- Section 3.** The funds for the ADA ramps shall be taken from the Road District Fund (#11).
- Section 4.** The Fiscal Officer is hereby authorized to make payments to RA Miller Construction in an amount not to exceed \$291,300.00 when finished and the Public Works Director has given approval of the pay request.
- Section 5.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.
- Section 6.** It is hereby certified that all formal actions of the Board of Trustees of


Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 7. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.




