



**RESOLUTION G2018-58**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH COVERALL FOR CLEANING SERVICES FOR THE SAFETY CENTER NOT TO EXCEED TWELVE THOUSAND EIGHT HUNDRED FOUR DOLLARS AND NO CENTS (\$12,804.00) PER YEAR**

**WHEREAS**, it has been determined by the Trustees that the Safety Center is a large facility and is used by many different groups, residents, government agencies, and for our contracted services who are not employees; and

**WHEREAS**, the Director of Public Works has recommended to the Township Administrator that the Board hire an outside cleaning company to maintain the portions of the building that are occupied by the public and the contracted services as listed in the agreement; and

**WHEREAS**, it is necessary to maintain the buildings for the safe and effective operation of Symmes Township public works services and the general public; and

**WHEREAS**, the Director of Public Works has reviewed all bids and finds that Coverall to have the lowest responsive and responsible bid; and

**WHEREAS**, pursuant to Ohio Revised Code §504.04, the Board of Trustees have the authority to enter into an agreement with Coverall for cleaning services for the Safety Center.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby authorizes the Township Administrator to enter into an agreement with Coverall in the amount of Twelve Thousand Eight Hundred Four Dollars (\$12,804.00).

**Section 2.** The funds for the cleaning service shall be taken from the Safety Services Levy Fund (#20).

**Section 3.** The Fiscal Officer is hereby authorized to make payment to Coverall in the amount of \$12,804.00 upon final approval of the Public Works Director.

**Section 4.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of

this Resolution upon its first reading.



**Section 6.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.


