



RESOLUTION G2018-36

**RESOLUTION AUTHORIZING ACCEPTANCE OF STREET PAVING BIDS AND
AWARDING THE CONTRACT TO BARRETT PAVING IN THE AMOUNT OF
\$440,699.50**

WHEREAS, on March 17th and 24th Symmes Township advertised for paving in the newspaper and website and set a bid date of March 29, 2018 at 2:00 p.m.; and

WHEREAS, it is necessary to maintain certain streets for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, the following bids were received for the 2018 paving program

1. Roberts Paving, Inc. - \$443,118 (base) + \$26,500 (supplement) = \$460,618.00 (total bid);
2. JK Meurer Corp. - \$446,825 (base) + \$11,825 (supplement) = \$458,650.00 (total bid);
3. John R. Jurgenson - \$442,756 (base) + \$11,500 (supplement) = \$458,256.00 (total bid);
4. Barrett Paving - \$425,749.50 (base) + \$14,950 (supplement) = \$440,699.50

WHEREAS, bids were accepted and reviewed by the Public Works Director and the Township Administrator recommends that the Trustees award the contract to Barrett Paving in the amount of Four Hundred Forty Thousand Six Hundred Ninety-Nine Dollars and Fifty Cents (\$440,699.50); and

WHEREAS, pursuant to Ohio Revised Code §5571.01, the Board of Trustees may construct, reconstruct, resurface, or improve any public road or part thereof under its jurisdiction within its township.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby accept the bids for the paving in the Township and award the bid to Barrett Paving in the amount of Four Hundred Forty Thousand Six Hundred Ninety-Nine Dollars and Fifty Cents (\$440,699.50).

Section 2. The Township Administrator is authorized to sign the contract and complete any necessary paperwork to award the bid.

Section 3. The funds for the paving shall be taken from the Road District Fund (#11).

Section 4. The Fiscal Officer is hereby authorized to make payment to Barrett Paving in the amount of Four Hundred Forty Thousand Six Hundred Ninety-Nine Dollars and Fifty Cents (\$440,699.50), once the work is finished and the Public Works Director has given final approval of the project.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.


Section 6. Finds and determines that all formal actions of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without limitation) Ohio Revised Code §121.22, except as otherwise permitted thereby.

Section 7. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.


