



RESOLUTION G2025-91

RESOLUTION AUTHORIZING ACCEPTANCE OF BIDS FOR THE FIELDS ERTEL ROAD SIDEWALK PROJECT AND AWARDING THE CONTRACT TO ADLETA INC. IN THE AMOUNT OF ONE MILLION ONE HUNDRED TWENTY-NINE THOUSAND NINETY-EIGHT DOLLARS AND 88 CENTS (\$1,129,098.88)

WHEREAS, on September 11th and September 25th Symmes Township advertised for bids for the Fields Ertel Road sidewalk project in the newspaper and website and set a bid date of October 3, 2025 at 10:00 a.m.; and

WHEREAS, the Trustees have determined that they would like to expand the sidewalk network throughout the Township which includes connecting parks to the neighborhoods located within the Township and making connections between neighborhoods; and

WHEREAS, the Trustees submitted an application to the Southwest Ohio Regional Transit Authority (SORTA) to fund the installation of sidewalks on Fields Ertel Road from Mason Montgomery Road to Montgomery Road and on Mason Montgomery Road to Chapelsquare; and

WHEREAS, the Trustees have entered into a grant agreement with SORTA for a transit infrastructure funds project; and

WHEREAS, the following bids were received for the Fields Ertel Road Sidewalk Project:

1. Adleta Inc. - \$1,129,098.88
2. Majors Enterprises Inc. - \$1,140,629.50
3. Fred A. Newmann Co. - \$1,255,261.72
4. Prus Construction Co. - \$1,280,382.77
5. Ford Development Corp. - \$1,345,750.00
6. Fillmore Construction LLC - \$1,642,965.50

WHEREAS, bids were accepted and reviewed by the Township Administrator and Choice One Engineering and the Township Administrator recommends that the Trustees award the contract to Adleta Inc. in the amount of \$1,129,098.88; and

WHEREAS, pursuant to Ohio Revised Code §5571.01, the Board of Trustees may construct, reconstruct, resurface, or improve any public road or part thereof under its jurisdiction within its township.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby accept the bids for the Fields Ertel Road Sidewalk Project and award the bid to Adleta Inc. in the amount of One Million One Hundred Twenty-Nine Thousand Ninety-Eight Dollars and Eighty-Eight Cents (\$1,129,098.88).

Section 2. The Township Administrator is authorized to sign the contract and complete any necessary paperwork to award the bid.

Section 3. The funds for the paving shall be taken from the Tax Increment Financing Fund (#2902).

Section 4. This project will be funded partially by a grant received from Southwest Ohio Regional Transit Authority (SORTA) for the installation of sidewalks on Fields Ertel Road from Mason Montgomery Road to Montgomery Road and on Mason Montgomery Road to Chapelsquare, new ADA curb ramps, pedestrian signal added at I-71 exit ramps with pedestrian phase which will improve pedestrian service to metro bus stops and the park and ride; the Southwest Regional Ohio Transit Authority (SORTA) has agreed to reimburse Symmes Township up to \$445,770.00 for these improvements upon receipt of an invoice from Symmes Township for the work performed.

Section 5. The Fiscal Officer is hereby authorized to make payment to Adleta Inc. in the amount of One Million One Hundred Twenty-Nine Thousand Ninety-Eight Dollars and Eighty-Eight Cents (\$1,129,098.88) once the work is finished and the Public Works Director has given final approval of the project.

Section 6. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

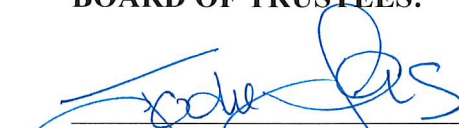

Section 8. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.

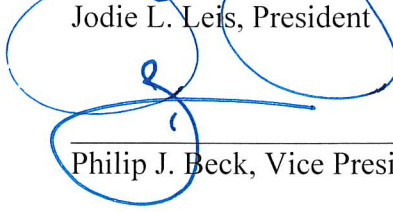
