



**RESOLUTION G2017-019**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH VO BUILDERS INC. TO REGRADE AN EXISTING BALLFIELD AT SYMMES PARK IN THE AMOUNT OF FOUR THOUSAND EIGHT HUNDRED DOLLARS (\$4,800.00)**

**WHEREAS**, it has been determined by the Trustees that the ballfield in Symmes Park requires maintenance and needs to be regarded to avoid trips and falls on the field; and

**WHEREAS**, the Director of Public Works has recommended to the Township Administrator that the field be regarded due to a 3" lip on the infield; and

**WHEREAS**, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public; and

**WHEREAS**, the Director of Public Works has reviewed all bids and finds that VO Builders Inc. to have the best bid; and

**WHEREAS**, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby authorizes the Township Administrator to enter into an agreement with VO Builders Inc. in the amount of Four Thousand Eight Hundred Dollars (\$4,800.00).

**Section 2.** The funds for the ballfield shall be taken from the Parks Levy Fund (#12A).

**Section 3.** The Fiscal Officer is hereby authorized to make payment to VO Builders Inc., PO Box 31138, Cincinnati, Ohio 45231 in the amount of \$4,800.00 upon final approval of the Public Works Director.

**Section 4.** Upon majority vote does hereby dispense with the requirement that this


Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.


**Section 5.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.


