



**RESOLUTION G2017-016**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO PURCHASE A LAWNMOWER FOR THE PARKS DEPARTMENT FROM BUCHANANS POWER EQUIPMENT/JOHN DEERE IN THE AMOUNT OF SIX THOUSAND EIGHT HUNDRED SIXTY-TWO DOLLARS AND SEVENTY-THREE CENTS (\$6,862.73)**

**WHEREAS**, it has been determined by the Trustees that the lawnmower the Township purchased in 2006 has reached its useful life; and

**WHEREAS**, the Director of Public Works has recommended to the Township Administrator that the lawnmower be traded in and a new one purchased; and

**WHEREAS**, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public; and

**WHEREAS**, the Township participates in the State of Ohio, State Term Discount Program, Schedule #800276; therefore the Township would not be required to bid out the equipment to multiple vendors; and

**WHEREAS**, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby authorizes the Township Administrator to purchase a lawnmower for the parks department from Buchanan's Power Equipment/John Deere in the amount of Six Thousand Eight Hundred Sixty-Two and Seventy-Three Cents (\$6,862.73).

**Section 2.** The funds for the park lawnmower shall be taken from the Parks Levy Fund (#12).

**Section 4.** The Fiscal Officer is hereby authorized to make payment to Buchanan's Power Equipment/John Deere in the amount of \$6,862.73.






**Section 6.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.


