



RESOLUTION G2017-039

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO PURCHASE REPLACEMENT CAMERAS FOR STONEBRIDGE AND BLONG PARKS FROM EXECUTIVE SECURITY & TECHNOLOGY IN AN AMOUNT NOT TO EXCEED SEVEN THOUSAND DOLLARS (\$7,000.00)

WHEREAS, it has been determined by the Trustees that the cameras at Stonebridge and Blong Parks need to be replaced; and

WHEREAS, the Director of Public Works has recommended to the Township Administrator that the cameras at Stonebridge and Blong Parks be replaced due to damage sustained by lightning strikes at the water tower; and

WHEREAS, it is necessary to maintain the parks and all of the buildings for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, the Director of Public Works has reviewed all bids and finds that Executive Security and Technology has the best price; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to purchase replacement cameras for Stonebridge and Blong Parks from Executive Security and Technology in an amount not to exceed Seven Thousand Dollars and No Cents (\$7,000.00).

Section 2. The funds for the cameras shall be taken from the Parks Levy Fund (#12A).

Section 3. The Fiscal Officer is hereby authorized to make payment to Executive Security and Technology, PO Box 18898, Fairfield, Ohio 45018, in an amount not to exceed \$7,000.00 upon final approval of the Public

Works Director.



Section 5. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.




