



RESOLUTION G2017-037

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO HIRE M & M PAINTING TO SCRAPE AND PAINT WHERE NECESSARY AT THE MEADE HOUSE IN THE AMOUNT NOT TO EXCEED FIVE THOUSAND ONE HUNDRED DOLLARS (\$5,100.00)

WHEREAS, it has been determined by the Trustees that the Meade House needs to be maintained on a regular basis; and

WHEREAS, the Director of Public Works has recommended to the Township Administrator that the house be scraped and primed where needed and paint all of the trim and all four chimneys; and

WHEREAS, it is necessary to maintain the parks and all of the buildings for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, the Director of Public Works has reviewed all bids and finds that M & M Painting to have the best bid; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to hire M & M Painting to paint at the Meade House in an amount not to exceed Five Thousand One Hundred Dollars and No Cents (\$5,100.00).

Section 2. The funds for the fence shall be taken from the Parks Levy Fund (#12A).

Section 3. The Fiscal Officer is hereby authorized to make payment to M & M Painting, 3240 Martin Road, Pleasant Plain, Ohio 45162, in an amount not to exceed \$5,100.00 upon final approval of the Public Works

Director.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 5. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
