



RESOLUTION G2017-030

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO
PURCHASE PLAYGROUND EQUIPMENT FROM WALNUT GROVE
PLAYGROUNDS FOR HOPEWELL MEADOWS PARK IN THE AMOUNT OF
\$19,457.00**

WHEREAS, it has been determined by the Trustees that they would like to provide a low impact activity at Hopewell Meadows Park; and

WHEREAS, on May 10, 2017 the staff met with a representative from Walnut Grove Playgrounds and reached a determination on what type of equipment they recommend to the Trustees to purchase; and

WHEREAS, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, Walnut Grove Playgrounds participates in the TIPS USA program which is similar to State Term Contract where Symmes Township is a member therefore the Township would not be required to bid out the equipment to multiple vendors; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to purchase outdoor exercise equipment from Walnut Grove Playgrounds in the amount of Nineteen Thousand Four Hundred Fifty-Seven Dollars and No Cents (\$19,457.00).

Section 2. The funds for the park improvements shall be taken from the Parks Levy Fund (#12).

Section 3. The Fiscal Officer is hereby authorized to make payment to Walnut Grove Playgrounds in the amount of \$19,457.00 once the equipment has been delivered and the Public Works Director has given final

approval of the project.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 5. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.


