



RESOLUTION G2017-21

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH HADDIX TREE SERVICE INC. TO REMOVE A TREE IN THE RIGHT-OF-WAY ON MUNSON STREET IN THE AMOUNT OF TWO THOUSAND EIGHT HUNDRED DOLLARS (\$2,800.00)

WHEREAS, a tree is partially dead on Munson Street and could potentially fall down into the roadway and damage property or persons in the township; and

WHEREAS, the Director of Public Works has recommended to the Township Administrator that the tree be removed before someone gets hurt and property is damaged; and

WHEREAS, bids were accepted and reviewed by the Public Works Director and the Township Administrator recommends that the Trustees enter into an agreement with Haddix Tree Service, Inc. in the amount of Two Thousand Eight Hundred Dollars (\$2,800.00) to remove the existing tree from the right-of-way; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

- Section 1.** The Symmes Township Trustees hereby authorize the Township Administrator to enter into an agreement with Haddix Tree Service Inc. to remove a tree in the right-of-way on Munson Street in the amount of Two Thousand Eight Hundred Dollars (\$2,800.00).
- Section 2.** The Township Administrator is authorized to sign and/or complete any necessary paperwork to award the bid.
- Section 3.** The funds for the nuisance abatement shall be taken from the Motor Vehicle License Tax Fund (#02).
- Section 4.** That line item 2-A-9 be amended from \$1,000.00 to \$3,800.00 in the appropriations budget.
- Section 5.** The Fiscal Officer is hereby authorized to make payment to Haddix Tree Service Inc., PO. Box 113, 322 Riverside Drive, Loveland, Ohio 45140, once the tree is removed from the site and the Public Works Director has given final approval.



Section 7. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.






