



RESOLUTION G2017-020

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO SIGN
A CONTRACT WITH CANTRELL FENCING COMPANY TO MAKE THE
NECESSARY REPAIRS AND REPLACE CERTAIN SECTIONS OF THE FENCE
AS NECESSARY AT SYMMES PARK IN THE AMOUNT OF NINETEEN
HUNDRED DOLLARS (\$1,900.00)**

WHEREAS, it has been determined by the Trustees that the dog run in Symmes Park requires maintenance and needs to be repaired and/or replaced; and

WHEREAS, the Director of Public Works has recommended to the Township Administrator that the fence be repaired and/or replaced; and

WHEREAS, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, the Director of Public Works has reviewed all bids and finds that Cantrell Fence Company to have the best bid; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator sign a contract with Cantrell Fence Company to make the necessary repairs and replace certain sections of fence as necessary At Symmes Park in the amount of One Thousand Nine Hundred Dollars and No Cents (\$1,900.00).

Section 2. The funds for the fence shall be taken from the Parks Levy Fund (#12A).

Section 3. The Fiscal Officer is hereby authorized to make payment to Cantrell Fence Company, 2202 State Route 28, Goshen, Ohio 45122, in the amount of \$1,900.00 upon final approval of the Public Works Director.



Section 5. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.




