**RESOLUTION APPROVING PAY
ADJUSTMENTS FOR TOWNSHIP EMPLOYEES FOR FISCAL YEAR 2017**

WHEREAS, the Symmes Township Personnel Policy Manual provides for salary adjustments for Township employees;

WHEREAS, the Board of Trustees of Symmes Township, Hamilton County, Ohio, has reviewed the 2016 evaluations for Township employees; and

WHEREAS, the Township Administrator has recommended that all of the employee receive a raise in their base hourly rate of pay.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The salary adjustments for 2017 for each Symmes Township employee as reflected below are hereby adopted and approved.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.


Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
