



RESOLUTION G2017-65

RESOLUTION AUTHORIZING ACCEPTANCE OF BIDS FOR THE LEBANON ROAD SIDEWALK PROJECT AND AWARDING THE CONTRACT TO FORD DEVELOPMENT IN THE AMOUNT OF \$82,894.00

WHEREAS, on August 16th and August 23rd Symmes Township advertised for bids for the Lebanon Road sidewalk project in the newspaper and website and set a bid date of September 6, 2017 at 2:00 p.m.; and

WHEREAS, at the regular Trustees Meeting on October 3, 2017 all bids were rejected because only one bid was received and it was over the 10% allowance; and

WHEREAS, on September 20th and September 27th Symmes Township advertised for bids for a second time in the newspaper and website and set a bid date of October 18, 2017; and

WHEREAS, the Trustees have determined that they would like to expand the sidewalk network throughout the Township which includes connecting parks to the neighborhoods located within the Township; and

WHEREAS, the following bids were received for the 2017 Lebanon Road sidewalk project:

1. Schweitzer Construction - \$84,941.95
2. **Ford Development - \$82,894.00**
3. Brown Construction - \$84,988.00
4. Adleta Construction - \$115,720.00
5. Prus Construction - \$159,666.00
6. Rack & Ballauer Excavating - \$137,384.00

WHEREAS, bids were accepted and reviewed by the Public Works Director and the Township Administrator recommends that the Trustees award the contract to Ford Development in the amount of Eighty Two Thousand Eight Hundred Ninety-Four Dollars and No Cents (\$82,894.00); and

WHEREAS, pursuant to Ohio Revised Code §5571.01, the Board of Trustees may construct, reconstruct, resurface, or improve any public road or part thereof under its jurisdiction within its township.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby accept the bids for the Lebanon Road Sidewalk project and award the bid to Ford Development in the amount of Eighty Two Thousand Eight Hundred


Ninety-Four Dollars and No Cents (\$82,894.00).

- Section 2.** The Township Administrator is authorized to sign the contract and complete any necessary paperwork to award the bid.
- Section 3.** The funds for the paving shall be taken from the Park District Fund (#12).
- Section 4.** The Fiscal Officer is hereby authorized to make payment to Ford Development in the amount of \$82,894.00 once the work is finished and the Public Works Director has given final approval of the project.
- Section 5.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.
- Section 6.** That it is hereby found and determined that all formal actions of the Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
- Section 7.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.




