



RESOLUTION C2016-01

**Resolution Amending Rules and Regulations
and Revising Rate Schedule
for Township Cemeteries**

WHEREAS, the Board of Trustees of Symmes Township, Hamilton County, Ohio established and adopted rules and regulations for township cemeteries on March 6, 1990 by passage of Resolution C-9001; and

WHEREAS, the Board of Trustees of Symmes Township established and adopted a Rate Schedule for the cost of grave spaces, opening and closing fees, foundations, and others pursuant to Resolution C-9001; and

WHEREAS, revisions to the adopted rules and regulations and to the Rate Schedule have been made pursuant to Resolutions C-9601, C-0001, C-0201, C-0301, C-0302, C-0401, C-0701, C2011-01, C2011-02, C2013-01 and C2015-01 adopted May 21, 1996, May 19, 2000, September 3, 2002, July 1, 2003, October 7, 2003, September 7, 2004, June 5, 2007, June 1, 2010, October 1, 2013 and September 1, 2015; and

WHEREAS, the Board of Trustees of Symmes Township has determined the need to revise the Rate Schedule;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Symmes Township:

Section 1. Hereby revises the Cemetery Rate Schedule as follows:
 Opening & Closing (includes lowering device, set-up and tent):
 Weekday (8:30 a.m. to 2:00 p.m.) . ~~\$950.00~~ 1000.00
 Saturday (8:30 a.m. to 2:00 p.m.) ~~\$1500.00~~ 1600.00

Interment of ashes ~~\$500.00~~ 550.00
 including 2x5 grave ~~800.00~~ 900.00

Infant burial	\$400.00 <u>450.00</u>
including 2x5 grave	700.00 <u>800.00</u>
Foundations (per square inch)	\$.70 <u>\$.75</u>
Dis-interment	\$2000.00 <u>\$3000.00</u>
Grave Space (up to 4 graves) to residents of Symmes Township	\$650.00 <u>\$700.00</u>
Grave Space (5 or more graves) to residents of Symmes Township . .	\$1600.00 <u>\$1700.00</u>
Grave Space non-residents of Symmes Township	\$1600.00 <u>\$1700.00</u>

Section 2. This Resolution shall be effective November 15, 2016;
and

Section 3. The Township Fiscal Officer is directed to cause the
revised Rate Schedule to be published once a week for
two consecutive weeks in a newspaper of general
circulation within the Township.
