



**RESOLUTION G2025-97**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO RENEW A CONTRACT WITH RIVER OAKS SERVICES FOR GRASS MOWING IN THE CANNON TRIANGLE, UNION CEMETERY, KERR CEMETERY AND WALDSCHMIDT CEMETERY IN THE AMOUNT OF FIFTY-SIX THOUSAND FOUR HUNDRED TWENTY DOLLARS AND NO CENTS (\$56,420.00)**

**WHEREAS**, it is necessary to maintain the building grounds, parks, and road rights-of-way for the safe and effective operation of Symmes Township public works services and the general public.

**WHEREAS**, River Oaks Services have offered a renewal of their contract accepted by the township March 4, 2025 for grass mowing in 2026 in the cannon triangle, Union Cemetery, Kerr Cemetery and Waldschmidt Cemetery; and

**WHEREAS**, the contract was reviewed by the Public Works Director and the Township Administrator recommends that the Trustees renew the contract with River Oaks Services at the following cost:

1. River Oaks Services in the amount of \$2,170.00 per cut or \$56,420.00 for the entire year to mow Cannon Triangle (St. Rt. 126 & Kuglermill), Union Cemetery, Kerr Cemetery and Waldschmidt Cemetery.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby accept the bid for the mowing in the Township and award the bid to River Oaks Services for an additional year offered in their current contract in the amount of \$2,170.00 per cut or \$56,420.00 for 2026 to mow Cannon Triangle (St. Rt. 126 & Kuglermill), Union Cemetery, Kerr Cemetery and Waldschmidt Cemetery, all of which includes Twenty-Six cuts for the year.

**Section 2.** The Township Administrator is authorized to sign the contract and complete any necessary paperwork to award the bid.

**Section 3.** The funds for the mowing shall be taken from the Cemetery (2041) Funds.

**Section 4.** The Fiscal Officer is hereby authorized to make payments to River Oaks per cut monthly when finished and the Public Works Director has given approval of the pay request.

**Section 5.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

**Section 6.** It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**Section 7.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.






