



RESOLUTION G2025-110

RESOLUTION AMENDING G2025-48 AUTHORIZING THE PURCHASE OF APPARATUS PARTS AND REPAIRS FROM VARIOUS VENDORS FOR TOWER 61 IN AN AMOUNT NOT TO EXCEED SIXTY-SEVEN THOUSAND EIGHT HUNDRED SIXTY TWO DOLLARS AND TWENTY-SIX CENTS (\$67,862.26)

WHEREAS, it has been recommended by the Fire Chief and determined by the Trustees that they would like to purchase parts and have apparatus repaired; and

WHEREAS, it is necessary to maintain the equipment for the safe and effective operation of Symmes Township Public Safety Divisions and the general public; and

WHEREAS, Symmes Township participates in the Ohio State Term Contract program therefore the Township would not be required to bid out the equipment to multiple vendors; and

WHEREAS, pursuant to Ohio Revised Code §505.37, the Board of Trustees may purchase, lease, lease with an option to purchase, or otherwise provide any fire apparatus, mechanical resuscitators, underwater rescue and recovery equipment, or other fire equipment, appliances, materials, fire hydrants, and water supply for firefighting and fire and rescue purposes that seems advisable to the board.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Board of Township Trustees hereby authorizes the purchase of apparatus parts and repairs for Tower 61 from the following vendors, Truck Pro for all brake parts in an amount not to exceed Eleven Thousand Five Hundred Dollars and no cents (\$11,500), RS Catz for suspension bushings, brake repairs and labor for chassi repairs in an amount not to exceed Eight Thousand Dollars and no cents (\$8,000.00) and Heritage Fire Apparatus for repairs to the yoke, HUX bolts on the ladder, lift and extend cylinder rebuild in an amount not to exceed Forty-Eight Thousand Three Hundred Sixty-Two Dollars and Twenty-Six Cents (\$48,362.26) for the combined repair amount not to exceed Sixty-One Thousand Five Hundred Dollars and No Cents (\$67,862.26).

Section 2. That the appropriations line item for 2196-220-323-0000 be increased \$31,713.83 to a total amount of \$156,713.83.

Section 3. The Fiscal Officer is hereby authorized to expend funds to pay Truck Pro in the amount not to exceed Eleven Thousand Five Hundred Dollars and no cents (\$11,500.00), RS Catz in the amount not to exceed Eight Thousand Dollars and no cents (\$8,000.00), and Heritage Fire Apparatus in the amount not to exceed Forty-Eight Thousand Three Hundred Sixty-Two Dollars and Twenty-Six Cents (\$48,362.26) for a combined repair amount not to exceed Sixty-Seven Thousand Eight Hundred Sixty Two Dollars and Twenty-Six Cents (\$67,862.26) from the Safety Services Fund (#2196) once the equipment has been repaired and the Fire Chief has given final approval of the project.

Section 4. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.




