**RESOLUTION APPROVING THE FINAL REVENUES AND EXPENDITURES
FOR SYMMES TOWNSHIP FOR FISCAL YEAR 2025**

The Board of Township Trustees of Symmes Township, Hamilton County, Ohio, met in SPECIAL MEETING session on the 30TH day of December 2025, at the office of Symmes Township Trustees with the following members present: Trustee Beck, Trustee Bryant and Trustee Leis. Trustee Jodie L. Leis moved the adoption of the following Resolution:

WHEREAS, this Board of Trustees of Symmes Township in accordance with the provisions of law has previously adopted a Tax Budget, Temporary and Final Appropriations for the fiscal year commencing January 1st, 2025, and ending December 31, 2025; and

WHEREAS, it is necessary to approve Final Revenues and Expenditures for the Fiscal Year 2025 per the attached reports.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.






