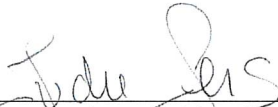

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.

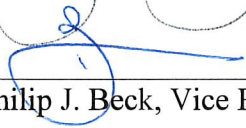

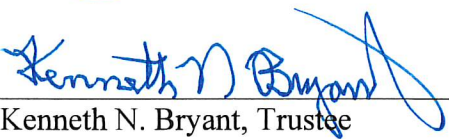

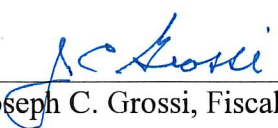
