RESOLUTION AUTHORIZING A CHANGE ORDER IN THE ADA COMPLIANT RAMP REPLACEMENT AND CONSTRUCTION PROJECT CONTRACT WITH BELGRAY, INC. IN THE AMOUNT OF FIVE THOUSAND SEVEN HUNDRED SIXTEEN DOLLARS AND EIGHTY-EIGHT CENTS (\$5,716.88)

WHEREAS, on October 7, 2025, the Township entered into a contract with Belgray, Inc. to replace multiple curb ramps with ADA compliant ramps throughout the township; and

WHEREAS, the total amount of the agreement was for \$73,532.00; and

WHEREAS, additional work was needed and not anticipated during the design phase of this project whereby the contractor had to remove and construct additional concrete walk and ramp; and

WHEREAS, the Township Administrator is recommending that the contract be increased to include the additional work in the amount of \$5,716.88; and

WHEREAS, the Board of Trustees of Symmes Township, Hamilton County, Ohio have determined to install sidewalks and crosswalks throughout Symmes Township to increase pedestrian traffic and make it safer for the community to walk in the township without having to walk along the roadways and provide safe crossings; and

WHEREAS, the Board of Trustees have decided to replace multiple curb ramps with ADA compliant ramps throughout the township; and

WHEREAS, the Board of Township Trustees hired an engineering firm, Choice One Engineering, to complete the necessary engineering required to satisfy the requirements of the Community Development Block Grant Program (CDBG) and to provide bid documents for contractors to review prior to bidding; and

WHEREAS, the Board of Township Trustees authorizes the change order with Belgray, Inc. due to the additional work needed to complete the project as required through the CDBG Program.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Symmes Township, Hamilton County, Ohio takes the following action:

- Section 1.** The Symmes Township Trustees hereby authorizes additional work and payment to Belgray, Inc. to complete the additional walk and curb ramp in the amount of Five Thousand Seven Hundred Sixteen Dollars and Eighty-Eight Cents (\$5,716.88).
- Section 2.** The Township Administrator is authorized to complete any necessary additional paperwork needed to authorize the additional work.
- Section 3.** That the Fiscal Officer is hereby authorized to expend funds to pay Belgray Inc. from the Road Levy Fund (#2193) in the amount of Five Thousand Seven Hundred Sixteen Dollars and Eighty Eight Cents (\$5,716.88).
- Section 4.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.
- Section 5.** The Board of Trustees of Symmes Township upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.
- Section 6.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
