**RESOLUTION APPROVING PAY
ADJUSTMENTS FOR TOWNSHIP EMPLOYEES FOR FISCAL YEAR 2022**

WHEREAS, the Symmes Township Personnel Policy Manual provides for salary adjustments for Township employees;

WHEREAS, the Board of Trustees of Symmes Township, Hamilton County, Ohio, has reviewed the 2020 evaluations for Township employees; and

WHEREAS, the Township Administrator has recommended that all of the employee receive a raise in their base hourly rate of pay.
