

RESOLUTION G2021-76

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO HIRE
JEFFREY WEIGEL TO THE POSITION OF SERVICE WORKER 1**

WHEREAS, the Township's Director of Public Works wishes to fill the position of Service Worker 1 that was vacated by Marcus Rose in May of 2021; and

WHEREAS, the Township Trustees are responsible for hiring all personnel in the township when there are vacancies; and

WHEREAS, the Township Trustees agree and approve to raise the beginning hourly salary from \$13.00 per hour to \$18.00 per hour; and

WHEREAS, Jeffrey Weigel is by reason of his training and experience competent to fill that position; and

WHEREAS, the Public Works Director is recommending that the Trustees hire Jeffrey Weigel as a Full-Time employee with the Service Department beginning September 13, 2021, with all the same benefits that all other Full-Time employees have per the personnel manual; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Township Administrator is hereby authorized to hire Jeffrey Weigel as a Service Worker 1 in the Service Department effective September 13, 2021.

Section 2. The starting hourly rate for this position will be Eighteen Dollars (\$18.00) per hour and will include all benefits given to all other Full-Time Employees. Mr. Weigel will be eligible for an increase in salary once he completes his CDL certification.

Section 3. This offer of employment is contingent upon Mr. Weigel passing a background, drug test and physical.

Section 4. Finds and determines that all formal action of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including

(without limitation) Ohio revised Code Section 121.22, except as otherwise permitted thereby.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
