

RESOLUTION G2021-69

**RESOLUTION AUTHORIZING THE REIMBURSEMENT OF MEDICAL
PREMIUM EXPENSES FOR THE FISCAL OFFICER**

WHEREAS, the Board of Trustees of Symmes Township, Hamilton County, Ohio provides medical insurance coverage for its full-time Symmes Township Employees and Elected Officials; and

WHEREAS, Symmes Township's policy has been to provide various medical insurance options to its employees and elected officials which includes coverage for the employee and their family; and

WHEREAS, Symmes Township has contracted with Medical Mutual of Ohio for medical insurance coverage since August of 2012 and has been renewed each year; and

WHEREAS, Symmes Township will continue its contract with Medical Mutual of Ohio to provide the same medical insurance which includes prescription drugs coverage beginning August 1, 2021 – through July 31, 2022; and

WHEREAS, Section 505.60 of the Ohio Revised Code allows a township to reimburse a township officer the cost of otherwise obtaining health care insurance for him or herself if they choose not to take the medical insurance being offered by the township; and

WHEREAS, the Fiscal Officer already has a supplemental health insurance policy for medical and prescription drugs and would like to continue with his plan and is asking the Board to reimburse him for those premiums dating back to April of 2020; and

WHEREAS, the Board of Trustees hereby agrees to reimburse the Fiscal Officer for those expenses.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the reimbursement of those expenses dating back to April 1, 2020.

Section 2. The cost of said expenses shall not exceed the cost of single plan through our current carrier which is Medical Mutual of Ohio:

- Single premium for 2020 - \$720.48
- Single premium for 2021 - \$773.75

Section 3. The Fiscal Officer is hereby authorized to pay those authorized

reimbursements from the General Fund (#1000) upon presentation of proper vouchers thereof.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 5. It is hereby certified that all formal actions of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without limitation) Ohio Revised Code §121.22, except as otherwise permitted thereby.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
