

RESOLUTION G2021-37

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO SIGN
AN AGREEMENT WITH ENVIRONMENTAL DESIGNS TO PAINT THE
INTERIOR BATHROOMS AT MEADE, HOME OF THE BRAVE AND
HOPEWELL PARKS IN THE AMOUNT OF \$10,495.00**

WHEREAS, it has been determined by Public Works Director that maintenance is needed in the park bathrooms for Meade, Home of the Brave and Hopewell Parks; and

WHEREAS, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the public; and

WHEREAS, the Director of Public Works recommends that we enter into an agreement with Environmental Designs to paint the interior of the restrooms; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to enter into an agreement with Environmental Designs to paint the interior of the bathrooms at Meade, Home of the Brave and Hopewell Parks in the amount of Ten Thousand Four Hundred Ninety-Five Dollars and No Cents (10,495.00).

Section 2. The funds for the painting shall be paid from the Parks Fund (#2171).

Section 3. The Fiscal Officer is hereby authorized to make payment to Environmental Designs in the amount of \$10,495.00 upon final approval of the Public Works Director.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 5. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all

deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
