

RESOLUTION G2021-39

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO AN AGREEMENT FOR TREE TREATMENTS AT VARIOUS PARKS, CEMETERIES AND GOVERNMENT BUILDINGS IN THE AMOUNT NOT TO EXCEED THIRTY-FOUR THOUSAND NINE HUNDRED SIXTEEN DOLLARS AND NO CENTS (\$34,916.00)

WHEREAS, it has been determined by the Trustees that all the parks require maintenance, and the trees need to be fertilized to promote healthy growth of the trees; and

WHEREAS, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, the Director of Public Works will review all bids to find the best bid and experience; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to enter into an agreement for tree treatments in the amount not to exceed Thirty-Four Thousand Nine Hundred Sixteen Dollars and No Cents (\$34,916.00).

Section 2. The funds for Symmes Safety Center shall be paid from the Safety Services Levy Fund (#2196), Waldschmidt Cemetery shall be paid from the Cemetery Fund (#2041), Home of the Brave Park shall be paid from the Rozzi Park Fund (#2172) and Symmes, Stonebridge, Seven Gables, Hopewell, and Blong Parks shall be paid from the Parks Levy Fund (#2171).

Section 3. The Fiscal Officer is hereby authorized to make payment for tree treatments in the amount not to exceed \$34,916.00 upon final approval of the Public Works Director.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of

this Resolution upon its first reading.

Section 5. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
