

RESOLUTION G2021-32

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO SIGN AN AGREEMENT FOR ENGINEERING SERVICES FOR BLONG PARK IN THE AMOUNT NOT TO EXCEED FIVE THOUSAND SEVEN HUNDRED DOLLARS AND NO CENTS (\$5,700.00)

WHEREAS, the township owns property at the corner of Kemper and Montgomery Roads known as Blong Park, a portion of land along vacated ROW of old Montgomery Road, and the corner of Blong and Montgomery Roads; and

WHEREAS, the township is being taxed for the portion of land at Blong and Montgomery Roads at a commercial rate even though it is not being utilized; and

WHEREAS, the Administrator suggested that we either use the property for a park or other governmental purpose or combine all of the properties into one use so that the taxes would no longer be assessed; and

WHEREAS, the Board of Township Trustees have decided to hire an engineering firm to complete the necessary work for a combination plat that will combine all the properties into one larger parcel of land.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Symmes Township, Hamilton County, Ohio takes the following action:

- Section 1.** That the Township Administrator is authorized to sign an agreement or necessary paperwork to provide engineering services for Blong Park and other parcels, in the amount not to exceed Five Thousand Seven Hundred Dollars and No Cents (\$5,700.00).
- Section 2.** That the Fiscal Officer is hereby authorized to expend funds to pay an engineering firm from the Parks Fund (#2171) in the amount not to exceed Five Thousand Seven Hundred Dollars and No Cents (\$5,700.00).
- Section 3.** That the line-item appropriation for 2171-610-316-0000 be increased in the amount of \$5,700.00 from \$1,200.00 to \$6,900.00.
- Section 4.** The Board of Trustees of Symmes Township upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon

its first reading.

Section 5. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
