

RESOLUTION G2021-28

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO
PURCHASE RECYCLED VIEWING CENTERS AND TABLES FOR VARIOUS
PARKS IN THE AMOUNT OF SIXTEEN THOUSAND TWO HUNDRED EIGHTY
DOLLARS AND TWENTY-SIX CENTS (\$16,280.26)**

WHEREAS, it has been determined by the Trustees that more tables are needed for the parks due to the increased usage and the Board would like to purchase viewing centers to display information about different features in the parks (i.e., bird blind, pollinator garden, etc.); and

WHEREAS, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the public; and

WHEREAS, the Director of Public Works recommends that we purchase these additional tables and viewing centers that are made from recycled materials; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to purchase recycled viewing centers and tables w/umbrellas in the amount of Ten Thousand Six Hundred Thirty-Five Dollars and Ninety Cents (\$10,635.90).

Section 2. The funds for the tables and viewing centers shall be paid from the Parks Fund (#2171).

Section 3. The Fiscal Officer is hereby authorized to make payment to Kirby Built in the amount of \$10,635.90 upon final approval of the Public Works Director.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 5. It is hereby certified that all formal actions of the Board of Trustees of

Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
