

**RESOLUTION G2021-27**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR  
TO SIGN A THREE-YEAR AGREEMENT WITH RUMPKE  
FOR TRASH, RECYCLING AND RESTROOM SERVICES**

**WHEREAS**, the Board of Trustees of Symmes Township, Hamilton County, Ohio has a need to provide trash, recycling, and restroom services for operations of the township which include all the township buildings and certain parks; and

**WHEREAS**, Ohio Revised Code Section 505.28 provides that the Board of Trustees may enter into written contracts with independent contractors for trash services; and

**WHEREAS**, Rumpke has demonstrated competence and expertise in providing trash, recycling, and restroom services; and

**WHEREAS**, the Board of Trustees has negotiated a contract with Rumpke that will provide trash, recycling, and restroom services to the Township at a reasonable value; and

**WHEREAS**, the Township Administrator has recommended that the Trustees enter into a contract with Rumpke to provide this service for the township.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Board of Trustees hereby authorizes the Township Administrator to sign a three-year agreement with Rumpke, 3800 Struble Road, Cincinnati, Ohio 45251 for Trash, Recycling, and Restroom Services.

**Section 2.** The Fiscal Officer is hereby authorized to make payments to Rumpke in the amount not to exceed \$1,316.35 a month or \$13,387.18 a year plus a fuel surcharge fee and will be paid from the Park Levy Fund (2171), Safety Services Fund (2196), Road Levy Fund (2193) and/or the General Fund (1000).

**Section 3.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.

**Section 4.** Finds and determines that all formal actions of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and any of its

committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without limitation) Ohio Revised Code §121.22, except as otherwise permitted thereby.

**Section 5.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.
