

RESOLUTION G2021-24

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO PURCHASE SECURITY CAMERAS FOR THE ADMINISTRATION BUILDING IN THE AMOUNT OF NINE THOUSAND SEVEN HUNDRED NINETY-SIX DOLLARS AND SEVENTY-SEVEN CENTS (\$9,796.77)

WHEREAS, the Administration and Service building lot recently had theft from trailers that are stored outside, and township equipment was stolen; and

WHEREAS, it has been determined by the Trustees that the Administration and Services buildings and parking lots need to be a safe place for the employees and protect the equipment that is not being stored inside a building; and

WHEREAS, it is necessary to maintain all buildings and parking lots for the safe and effective operation of Symmes Township public works services and the public; and

WHEREAS, the Township Administrator recommends that we purchase cameras from Professional Cabling Service (PCS) to deter theft.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to purchase cameras from PCS for the Administration and Service building lot in the amount of Nine Thousand Seven Hundred Ninety-Six Dollars and Seventy-Seven Cents (\$9,796.77).

Section 2. The funds for the cameras shall be paid from the General Fund (#1000).

Section 3. That an additional \$4,800.00 be appropriated for this purchase in the General Fund and that the total for the line item 1000-760-740-0000 be increase from \$5,000.00 to \$9,800.00.

Section 4. The Fiscal Officer is hereby authorized to make payment to PCS in the amount of \$9,796.77 upon final approval of the Public Works Director.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 6. It is hereby certified that all formal actions of the Board of Trustees of

Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 7. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
