

**RESOLUTION G2021-19**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH RIVER OAKS SERVICES, LLC. FOR LAWN TREATMENT AT SEVEN GABLES PARK IN THE AMOUNT OF THREE THOUSAND NINE HUNDRED FIFTEEN DOLLARS AND NO CENTS (\$3,915.00)**

**WHEREAS**, it has been determined by the Trustees that all the parks require maintenance and needs to be treated for weeds and to promote healthy growth of grass as well as sprayed for insects; and

**WHEREAS**, the Board mentioned at the last meeting that Seven Gables also needed to be treated for weeds and the Director of Public Works received a cost for that service; and

**WHEREAS**, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public; and

**WHEREAS**, the Director of Public Works has reviewed all bids and finds that River Oaks Services LLC. to have the best bid; and

**WHEREAS**, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby authorizes the Township Administrator to enter into an agreement with River Oaks Services LLC. in the amount of Three Thousand Nine Hundred Fifteen Dollars and No Cents (\$3,915.00).

**Section 2.** The funds for Seven Gables Park (\$3,915.00) shall be paid from the Park Fund (#2171).

**Section 3.** The Fiscal Officer is hereby authorized to make payment to River Oaks Services LLC. in the amount of \$3,915.00 upon final approval of the Public Works Director.

**Section 4.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

**Section 5.** It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**Section 6.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
