

**RESOLUTION G2021-17**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH RIVER OAKS SERVICES, LLC. FOR LAWN TREATMENT AND INSECT CONTROL IN VARIOUS LOCATIONS IN THE AMOUNT OF SEVENTEEN THOUSAND THREE HUNDRED THIRTY-SEVEN DOLLARS AND FIFTY CENTS (\$17,337.50)**

**WHEREAS**, it has been determined by the Trustees that Administration, Safety Center, Blong, Symmes and Home of the Brave Park and the three cemeteries requires maintenance and needs to be treated for weeds and to promote healthy growth of grass as well as sprayed for insects; and

**WHEREAS**, the Director of Public Works has recommended to the Township Administrator that all these locations be treated for weeds and insects; and

**WHEREAS**, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public; and

**WHEREAS**, the Director of Public Works has reviewed all bids and finds that River Oaks Services LLC. to have the best bid; and

**WHEREAS**, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby authorizes the Township Administrator to enter into an agreement with River Oaks Services LLC. in the amount of Seventeen Thousand Three Hundred Thirty-Seven Dollars and Fifty Cents (\$17,337.50).

**Section 2.** The funds for Home of the Brave Park (\$1,125.00) shall be paid from the Rozzi Parks Levy Fund (#2172), the cost Administration building (\$822.50) shall be paid from the General Fund (#1000), the cost of Blong, Meade, Stonebridge, and Symmes Park (\$3,650.00) shall be paid from the Park Fund (#2171), the cost of the Safety Center (\$1,970.00) shall be paid from the Safety Services Fund (#2196) and the funds for the cemeteries (\$9,770.00) shall be paid from the Cemetery Fund (#2041).

**Section 3.** That the appropriations for Contracted Services 2172-610-360-0000 be increased \$1,125.00 from \$80,550.00 to \$81,675.00 and the appropriations for Contracted Services 2041-410-360-0000 be increased \$9,770.00 from \$59,400.00 to \$69,170.00.

**Section 4.** The Fiscal Officer is hereby authorized to make payment to River Oaks Services LLC. in the amount of \$17,337.50 upon final approval of the Public Works Director.

**Section 5.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

**Section 6.** It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**Section 7.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
