

RESOLUTION G2021-18

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO
PURCHASE SECURITY CAMERAS FOR HOME OF THE BRAVE PARK IN
THE AMOUNT OF SEVENTEEN THOUSAND FOUR HUNDRED EIGHTY-ONE
DOLLARS AND SEVEN CENTS (\$17,481.07)**

WHEREAS, it has been determined by the Trustees that Home of the Brave Park needs to be a secure place where the residents can bring their children to play and feel safe; and

WHEREAS, the Director of Public Works has recommended to the Township Administrator that all parks should have cameras that are monitored just in case there is theft in the parks and to make the residents feel more safe; and

WHEREAS, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, the Director of Public Works recommends that we purchase cameras from Professional Cabling Service (PCS); and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to purchase cameras from PCS for Home of the Brave Park in the amount of Seventeen Thousand Four Hundred Eighty-One Dollars and Seven Cents (\$17,481.07).

Section 2. The funds for the cameras shall be paid from the Rozzi Parks Levy Fund (#2172).

Section 3. The Fiscal Officer is hereby authorized to make payment to PCS in the amount of \$17,481.07 upon final approval of the Public Works Director.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of

this Resolution upon its first reading.

Section 5. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
