

RESOLUTION G2021-16

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH TEAM ALL SPORTS TO TREAT STONEBRIDGE PARK AND THE BALLFIELDS AT HOME OF THE BRAVE PARK AND INSTALL LIMESTONE SCREENING MATERIAL IN THE WARNING TRACK IN THE AMOUNT OF FORTY-SIX THOUSAND FOUR HUNDRED FORTY-THREE DOLLARS AND EIGHTY-SEVEN CENTS (\$46,443.87)

WHEREAS, it has been determined by the Trustees that soccer fields and the ballfields at Home of the Brave Park requires maintenance and needs to be treated for weeds and to promote healthy growth of grass and that the dirt warning tracks at HOB continue to erode over into the dugouts during rain events which prompts the need to replace the dirt with limestone; and

WHEREAS, the Director of Public Works has recommended to the Township Administrator that the fields be treated at both locations, and the dirt warning tracks replaced with limestone; and

WHEREAS, it is necessary to maintain the parks for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, the Director of Public Works has reviewed all bids and finds that Team All Sports to have the best bid; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to enter into an agreement with Team All Sports in the amount of Forty-Six Thousand Four Hundred Forty-Three Dollars and Eighty-Seven Cents (\$46,443.87).

Section 2. The funds for the ballfields and limestone replacement shall be paid from the Rozzi Parks Levy Fund (#2172) and that the appropriation for line-item Contracted Services 2172-610-360-0000 be increased from

\$40,000.00 to \$80,550.00 and the cost for the soccer fields at Stonebridge shall be paid from the Parks Fund (#2171).

Section 3. The Fiscal Officer is hereby authorized to make payment to Team All Sports in the amount of \$40,544.22 upon final approval of the Public Works Director.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 5. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
