**RESOLUTION APPROVING THE FINAL REVENUES AND EXPENDITURES
FOR SYMMES TOWNSHIP FOR FISCAL YEAR 2022**

The Board of Township Trustees of Symmes Township, Hamilton County, Ohio, met in SPECIAL session on the 29TH day of December 2022, at the office of Symmes Township Trustees with the following members present: Trustee Beck and Trustee Bryant. Section 5. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
