**RESOLUTION AUTHORIZING THE PURCHASE OF THE BUTTERFLY IQ
ULTRASOUND SYSTEM FOR SYMMES TOWNSHIP MEDIC UNITS FROM
BUTTERFLY IQ – BFLY OPERATIONS INC. IN AN AMOUNT NOT TO
EXCEED SIX THOUSAND SEVEN HUNDRED THIRTY DOLLARS AND NO
CENTS (\$6,730.00)**

WHEREAS, the Fire Chief has recommended to purchase an ultrasound system for each medic unit in Symmes Township; and

WHEREAS, the additional gear has not been budgeted for; and

WHEREAS, the gear is a pocket-sized portable external ultrasound scanner and can be used for diagnostic ultrasound imaging and assessment of adult and pediatric patients' anatomical structures for various clinical applications such as cardiac, peripheral vessels, pulmonary function and obstetrics and is compatible with both apple and android mobile devices which can be used to collect the data; and

WHEREAS, it is necessary to maintain the equipment for the safe and effective operation of Symmes Township Public Safety Divisions and the general public; and

WHEREAS, pursuant to Ohio Revised Code §505.37, the Board of Trustees ...may purchase, lease, lease with an option to purchase, or otherwise provide any fire apparatus, mechanical resuscitators, underwater rescue and recovery equipment, or other fire equipment, appliances, materials, fire hydrants, and water supply for firefighting and fire and rescue purposes that seems advisable to the board.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the purchase of the Butterfly IQ ultrasound systems for each Medic Unit in Symmes Township from Butterfly IQ – BFLY Operations Inc. for the Loveland Symmes Fire Department in the amount not to exceed Six Thousand Seven Hundred Thirty Dollars and No Cents (\$6,730.00).

Section 2. The funds for the ultrasound devices shall be taken from the Safety Services Fund (#2196).

Section 3. The Fiscal Officer is hereby authorized to make payment to Butterfly IQ – BFLY Operations Inc. once the equipment has been delivered and the Fire Chief has given final approval of the project.

Section 4. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
