

RESOLUTION G2022-50

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH PAVEMENT TECHNOLOGY INC. FOR THE ROAD DEPARTMENT TO PURCHASE RECLAMITE IN THE AMOUNT NOT TO EXCEED FIFTY THOUSAND DOLLARS (\$50,000.00)

WHEREAS, the Township Road Department is responsible for roads and sidewalks maintenance throughout the township; and

WHEREAS, the Director of Public Works has indicated to the Township Administrator that we need to purchase Reclamite asphalt rejuvenator for various roadways in Symmes Township which will prolong the life of the roadway; and

WHEREAS, it has been determined by the Township Trustees that Reclamite asphalt rejuvenator is a necessary item that needs to be purchased every year to help preserve the roadways within the township and is authorizing the Township Administrator to purchase it.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorize the Township Administrator to purchase Reclamite Asphalt Rejuvenator for the Road Department from Pavement Technology Inc. in an amount not to exceed Fifty Thousand Dollars (\$50,000.00).

Section 2. The funds for the salt shall be taken from the Motor Vehicle License Fund (#2011), Gasoline Tax Fund (#2021), Road Levy Fund (#2193), and the Permissive Motor Vehicle Funds (#2231/2903).

Section 3. That the Appropriations in the Motor Vehicle Fund be increased \$10,000.00 in line item 2011-330-360-0000 from \$0.00 to \$10,000.00, and overall, from \$27,500.00 to \$37,500.00.

Section 4. The Fiscal Officer is hereby authorized to make payment to the necessary vendors once approval has been given by the Public Works Director.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of

this Resolution upon its first reading.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.

Section 7. It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
