

RESOLUTION G2022-39

**RESOLUTION AUTHORIZING ACCEPTANCE OF CURB
REPAIRS/REPLACEMENT BIDS AND AWARDING THE CONTRACT TO
ADLETA CONSTRUCTION IN THE AMOUNT OF FIVE HUNDRED THIRTY-
EIGHT THOUSAND ONE HUNDRED FIFTY DOLLARS AND NO CENTS
(\$538,150.00)**

WHEREAS, on February 5th, 12th, and 19th Symmes Township advertised for paving and curb repairs/replacement in the newspaper and website and set a bid date of February 25, 2022, at 2:00 p.m.; and

WHEREAS, it is necessary to maintain certain streets for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, the following bids were received for the 2022 curb repairs/replacement program:

WHEREAS, bids were accepted and reviewed by the Public Works Director and the Township Administrator recommends that the Trustees award the contract to Adleta Construction in the amount of Five Hundred Thirty-Eight Thousand One Hundred Fifty Dollars and No Cents (\$538,150.00) which includes the base bid; and

WHEREAS, pursuant to Ohio Revised Code §5571.01, the Board of Trustees may construct, reconstruct, resurface, or improve any public road or part thereof under its jurisdiction within its township.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby accept the bids for the curb repairs/replacement in the Township and award the bid to Adleta Construction in the amount of Five Hundred Thirty-Eight Thousand One Hundred Fifty Dollars and No Cents (\$538,150.00) which includes the base bid.

Section 2. The Township Administrator is authorized to sign the contract and complete any necessary paperwork to award the bid.

Section 3. The funds for the curb repairs/replacement shall be taken from the Road District Fund \$337,729.65 (#2193) and the ARPA Fund (#2272) \$200,420.35.

Section 4. The Fiscal Officer is hereby authorized to make payment to Adleta Construction in the amount of \$538,150.00 once the work is finished and the Public Works Director has given final approval of the project.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 6. Finds and determines that all formal actions of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without limitation) Ohio Revised Code §121.22, except as otherwise permitted thereby.

Section 7. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
