

RESOLUTION G2023-52

**RESOLUTION AUTHORIZING ACCEPTANCE OF STREET PAVING BIDS AND
AWARDING THE CONTRACT TO BARETT PAVING IN THE AMOUNT OF SEVEN
HUNDRED FIVE THOUSAND SIX HUNDRED FORTY DOLLARS AND NO CENTS
(\$705,640.00)**

WHEREAS, on March 13th and 20th, Symmes Township advertised for paving and repairs in the newspaper and website and set a bid date of April 5, 2023, at 2:00 p.m.; and

WHEREAS, it is necessary to maintain certain streets for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, the following bids were received for the 2023 paving program:

WHEREAS, bids were accepted and reviewed by the Public Works Director and the Township Administrator recommends that the Trustees award the contract to Barrett Paving in the amount of Seven Hundred Five Thousand Six Hundred Forty Dollars and No Cents (\$705,640.00) which includes the base bid and alternate bid; and

WHEREAS, pursuant to Ohio Revised Code §5571.01, the Board of Trustees may construct, reconstruct, resurface, or improve any public road or part thereof under its jurisdiction within its township.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby accept the bids for the paving in the Township and award the bid to Barrett Paving in the amount of \$705,640.00 which includes the base bid and alternate bid.

Section 2. The Township Administrator is authorized to sign the contract and complete any necessary paperwork to award the bid.

Section 3. The funds for the paving shall be taken from the Road District Fund (#2193), the Parks Fund (#2171) and the General Fund (#1000).

Section 4. That the appropriations for the Road Levy Fund be increased by

\$65,440.00 under Purchased Services 2193-330-360-0000 and a total overall to \$635,440.00 for that line item and a total of \$722,090.00 for the overall fund.

Section 5. The Fiscal Officer is hereby authorized to make payment to Barrett Paving in the amount of \$705,640.00 once the work is finished and the Public Works Director has given final approval of the project.

Section 6. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 7. Finds and determines that all formal actions of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without limitation) Ohio Revised Code §121.22, except as otherwise permitted thereby.

Section 8. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
