

RESOLUTION G2023-50

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO HIRE MAURICE K. BARNETT TO THE POSITION OF SERVICE WORKER 1

WHEREAS, the Public Works Director and Township Administrator wishes to fill the position of Service Worker 1 that was vacated by Brent Scott on January 6, 2023; and

WHEREAS, the Township Trustees are responsible for hiring all personnel in the township when there are vacancies; and

WHEREAS, the Township Trustees agree and approve the salary range from \$22.75 per hour to \$26.34 per hour for the Service Worker 1 Position; and

WHEREAS, Maurice K. Barnett is by reason of his education, training and experience the most competent to fill that position; and

WHEREAS, the Township Administrator is recommending that the Trustees hire Maurice K. Barnett as a Full-Time employee with the Service Department beginning May 1, 2023, with all the same benefits that all other Full-Time employees have per the personnel manual; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

- Section 1.** The Township Administrator is hereby authorized to hire Maurice K. Barnett as a Service Worker 1 in the Service Department effective May 1, 2023.
- Section 2.** The starting hourly rate for this position due to his previous experience will be Twenty-Five Dollars and Nine Cents (\$25.09) per hour and will include all benefits given to all other Full-Time Employees. Mr. Barnett will be eligible for an increase in salary at the same time as all the other employees at the end of 2023.
- Section 3.** This offer of employment also includes transfer of all sick leave and credited work time from his previous government position with ODOT, and two personal days.
- Section 4.** Finds and determines that all formal action of this Board concerning and relating to the passage of this resolution were taken in open meetings of

this Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without limitation) Ohio revised Code Section 121.22, except as otherwise permitted thereby.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
