

RESOLUTION G2023-43

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO HIRE
JAMES GOEBEL TO THE POSITION OF LABORER AS A PART-TIME EMPLOYEE**

WHEREAS, the Township Administrator and the Public Works Director wishes to fill the position of Laborer that was filled in 2021 but then vacated in 2022 when Jeffrey Weigel was promoted to Service Worker 1; and

WHEREAS, the Township Trustees are responsible for hiring all personnel in the township when there are vacancies; and

WHEREAS, the Township Trustees agree and approve the salary range from \$18.90 per hour to \$21.88 per hour for the Service Worker 1 Position; and

WHEREAS, James Goebel is by reason of his education, training and experience the most competent to fill that position; and

WHEREAS, the Township Administrator is recommending that the Trustees hire James Goebel as a Part-Time employee with the Service Department beginning March 27, 2023, with no benefits; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Township Administrator is hereby authorized to hire James Goebel as a Laborer in the Service Department effective March 27, 2023.

Section 2. The starting hourly rate for this position will be Eighteen Dollars and Ninety Cents (\$18.90) per hour and will include no benefits. Mr. Goebel will be eligible for an increase in salary at the same time as all the other employees at the end of 2023.

Section 3. This offer of employment also includes working no more than 28 hours per week which includes weekends as assigned (1,500 hours max per calendar year).

Section 4. Finds and determines that all formal action of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were taken in meetings

open to the public, in compliance with all legal requirements, including (without limitation) Ohio revised Code Section 121.22, except as otherwise permitted thereby.

Section 5. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
